This letter is to advise the Public Utilities Commission of Ohio (“Commission”) that the Ohio Energy Group (“OEG”) supports the Application of Ohio Edison Company, The Cleveland Electric Illuminating Company, and the Toledo Edison Company (collectively, “FirstEnergy”) for Waiver of ELR Annual Testing Requirement filed May 11, 2020 in the above-captioned proceeding.
