7           A.    I am employed by the Public Utilities Commission of Ohio (PUCO or  
8                Commission).

12   3.    Q.    Please briefly describe your educational and professional background.

13           A.    I received a Bachelor of Science Degree in Economics from the Ohio State  
14                University and a Master in Business Administration Degree from the  
15                University of Dayton.

17   4.    Q.    Please describe your work experience and professional training.

18           A.    I have been employed by the PUCO since 1987. Since that time I have  
19                progressed through various positions and was promoted in 2000 to my  
20                current position of Utility Specialist 3. In addition, I have worked on  
21                several joint Federal Communications Commission (FCC) and NARUC  
22                projects and audits, and served on the Midwest Independent System

Operator's (now Midcontinent System Operator, Inc.) Finance Committee as Vice-Chairman and Chairman. Also, in 2011, I was awarded the professional designation Certified Rate of Return Analyst (CRRRA) by the Society of Utility and Regulatory Financial Analysts. This designation is awarded based upon experience and successful completion of a written examination.

In 2000, I earned the Certified in Financial Management (CFM) designation, awarded by the Institute of Management Accountants. Also, I attended The Annual Regulatory Studies Program sponsored by The National Association of Regulatory Utility Commissioners (NARUC) and The Training for Utility Management Analyst also sponsored by NARUC.

5. Q. Have you testified in previous cases at the PUCO?

A. Yes. I have testified in numerous cases before the PUCO.

**Purpose of Testimony**

6. Q. What is your involvement in this proceeding?

A. I am responsible for determining if Dayton Power and Light (DP&L) exceeded the common equity threshold to be used in its Significantly Excessive Earnings Test (SEET). Based on the Staff's review of the

1 information provided in DP&L's applications, the Staff believes that DP&L  
2 fell well below the SEET threshold in 2016 and 2017.

3  
4 7. Q. What is the Staff's recommendation to the Commission in this proceeding?

5 A. The Staff recommends that the Commission find DP&L did not exceed the  
6 common equity threshold in 2016 or 2017, and that no refunds are  
7 warranted.

8  
9 8. Q. Has the Staff reviewed DP&L's earnings calculations?

10 A. Yes. The Staff has reviewed DP&L's calculations and supporting  
11 information, as well as conducted our own analysis. Based upon our  
12 analysis, the Staff does not believe the Company exceeded the SEET  
13 threshold in 2016 or 2017.

14  
15 9. Q. What methodology did Staff employ to determine significant excessive  
16 earnings?

17 A. The Staff used the stipulated threshold of 12 percent. This amount was  
18 agreed to in 16-0395-EL-SSO (Stipulation at page seven).

20 10. Q. Does this conclude your testimony?

21 A. Yes it does.
